<p>4. Parks Grant and City Logo: (6a on Agenda) Angela Lazarean, RARE intern, reported that Adair Village will receive a \$5,000 grant from the Benton County Commission on Children and Families. Angela had prepared this grant and it will focus on activities that support a Life Skills curriculum. Mayor Currier asked if \$5,000 is adequate for the program. Angela said that last year’s similar program was completed for just under \$5,000. Angela reported that she had contacted a Graphics Design and Arts class at University of Oregon and asked them to produce ideas for a city logo. Angela and Councilor King will meet with the class on January 16th. (5c on Agenda) Mike Silver, Police Services Consultant to Adair Village, presented information on Code Enforcement and Police Services Planning.</p> <ul style="list-style-type: none">• A review of the penalties attached to existing “Code Enforcement” ordinances provides too wide a range of discretion. After discussion with the CA, recommendation is to apply the lowest penalty amount in existing resolutions. Mike and the CA are reviewing a Public Protection ordinance, which would provide a more complete approach to the whole range of Nuisance, Animal Control, etc. ordinances now in place. This new ordinance will be brought to the next Council meeting.• Mike has been working to get additional animal control training for the City’s Code Enforcement Officer.• Mike has been meeting with a variety of individuals and agencies.<ul style="list-style-type: none">o He completed the first portion of his Scope of Work by presenting to the CA on December 27, 2007, a draft of Policies and Procedures. He met with CCIS (City-County Insurance Services) and they have already reviewed the first five sections and are supportive of the City’s approach to bringing in our own Police Services.o Mike met with the Benton County Sheriff’s Office (BCSO) to review service options with them. They cannot provide dedicated deputies, because they are undermanned at this point.o Rates for dispatch service with the Corvallis Police Department are much higher than anticipated and Mike will have further discussions with CPD. He will attend a meeting of their 911 Board on February 15th. <p>Gene Abraham asked a question concerning parking RVs on the side of a home and who had the responsibility for locating the water/sewer lines.
